

Certificate of Final Maximums
Municipal Elections Act, 1996 (MEA)

2018 Municipal Election
Candidates for Mayor –
Municipality of Brighton



Further to the Certificate of Preliminary Maximums (Form EL37) issued at the time of filing, and under the MEA, the Municipality must issue a certificate of applicable maximums to all candidates. The greater the number of electors identified using the voters' lists from the previous regular election and the current regular election shall apply to the prescribed formulas.

Campaign Expenses
under the Municipal Elections Act, 1996 (s.88.20)

In accordance with MEA, s.88.20(13), the Clerk shall calculate the maximum amounts permitted for campaign expenses for each office for which nominations were filed with him or her and give a certificate of the applicable maximum amounts to each candidate.

Parties, etc. After Voting Day
under the Municipal Elections Act, 1996 (s.88.20)

In accordance with MEA, s.88.20(13), the Clerk shall calculate the maximum amounts permitted for parties, etc. after Voting Day for each office for which nominations were filed with him or her and give a certificate of the applicable maximum amounts to each candidate.


Contributions to Own Campaign

In accordance with MEA, s.88.9.1(4), the Clerk shall calculate the maximum contributions to a candidate's own campaign for each office for which nominations were filed with him or her and give a certificate of the applicable maximum amounts to each candidate
