

The Municipality of Brighton Notice of Adoption of Official Plan Amendment No. 23

Take Notice that on June 22, 2026, the Council of the Corporation of the Municipality of Brighton adopted Official Plan Amendment No. 23 to the Official Plan of the Municipality of Brighton under Section 17 and 21 of the Planning Act, R.S.O., 1990. Amendment No. 23 was adopted by Council by By-law No. 057-2026.

A copy of Official Plan Amendment No. 23 accompanies this Notice.

Effect of Written and Oral Submissions on Decision: Public comments received through the public consultation process, including written and oral submissions, were considered by Council as part of the decision-making process leading to the adoption of Official Plan Amendment No. 23. The statutory public meeting was held in accordance with Section 17 of the *Planning Act*.

Purpose and Effect: The purpose of Official Plan Amendment No. 23 is to amend the Municipality of Brighton Official Plan to implement the Brighton Area Wide Efficient Land Use Plan (Brighton Secondary Plan), which establishes a comprehensive policy framework to guide long-term growth and development within designated Secondary Plan Areas.

The effect of Official Plan Amendment No. 23 is to introduce policies, a land use framework, infrastructure planning, and environmental protection measures for the Secondary Plan Areas and to establish land use designations, transportation networks, environmental policies, and a coordinated growth framework.

The lands affected by this Amendment include:

- Northeast Secondary Plan Area (Area 1);
- Northwest Secondary Plan Areas (Areas 2a and 2b); and
- Southwest Secondary Plan Area (Area 3).

These lands are located within the urban settlement boundary of the Municipality of Brighton.

The Amendment establishes a comprehensive planning framework addressing:

- Land Use;
- Community Facilities and Services;
- Transportation and Active Transportation;
- Environmental Protection; and
- Implementation and Phasing.

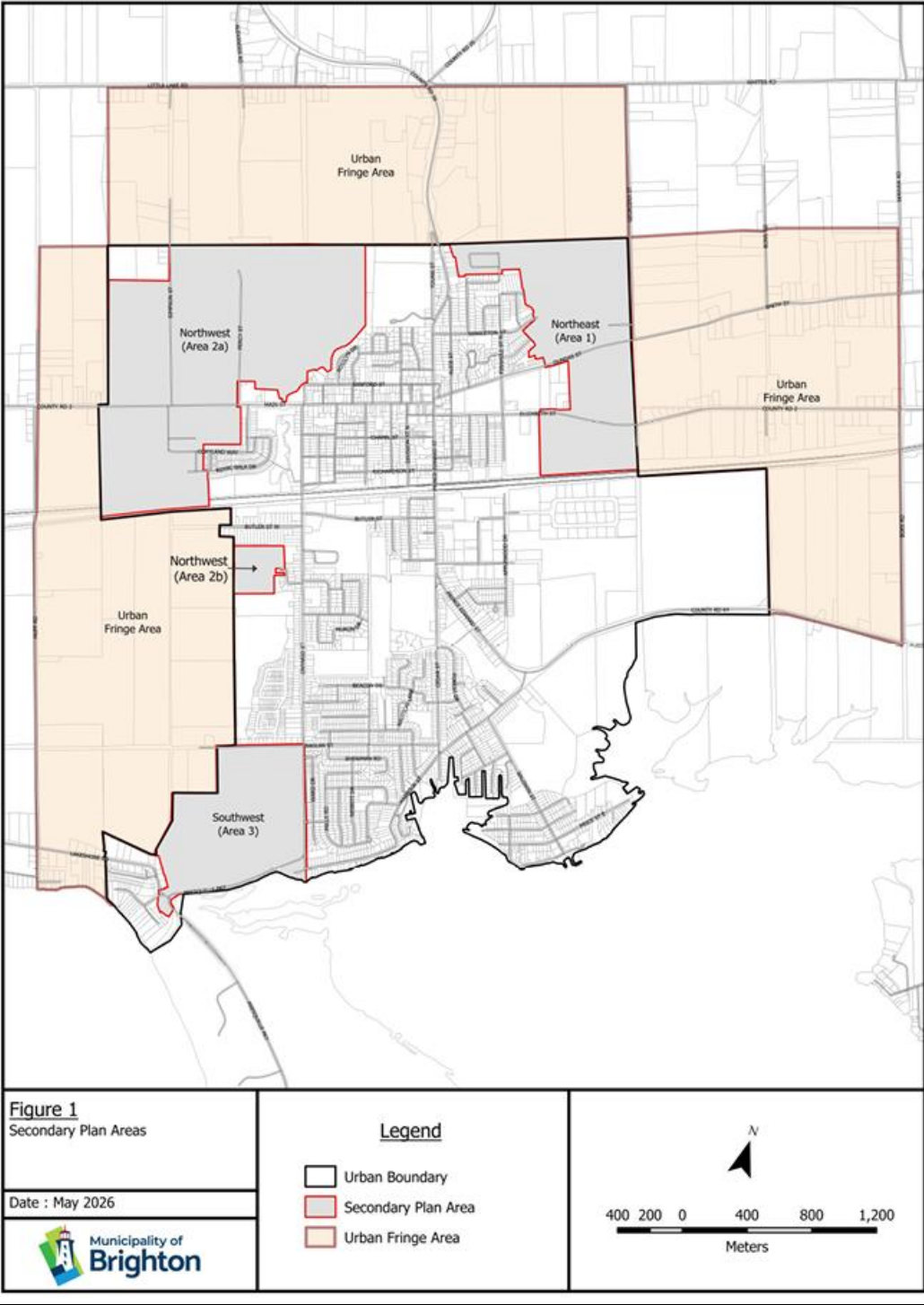
Notice of Decision

By-law No. 057-2026

Being a By-law to Adopt Amendment 23 Area Wide Efficient Land Use Plan (Brighton Secondary Plan) to the Official Plan for the Municipality of Brighton

Whereas, the Planning Act, R.S.O. 1990, c. P.13, as amended, authorizes municipalities to adopt Official Plans and amendments thereto;

And Whereas, Council for the Corporation of the Municipality of Brighton has considered Amendment No. 23 to the Official Plan;

And Whereas, Amendment No. 23 to the Official Plan of the Municipality of Brighton has been considered and recommended for adoption by the Municipality of Brighton Planning Council;

And Whereas, a Public Meeting on the proposed amendment has been held pursuant to the requirements of Section 17 of the Planning Act, R.S.O. 1990, Chapter P. 13, as amended;

And Whereas, Council deems it advisable and in the public interest to adopt Amendment No. 23 to the Official Plan;

Now Therefore - the Council of the Corporation of the Municipality of Brighton hereby enacts as follows:

1. That Amendment No. 23 to the Official Plan of the Municipality of Brighton, consisting of the attached explanatory text is hereby adopted.
2. The Clerk is hereby authorized and directed to forward Amendment 23 to the County of Northumberland for approval in accordance with the provisions of the Planning Act.
3. That the Clerk is hereby authorized to give notice of the adoption of Amendment No. 23 in accordance with the requirements under Section 17(23) of the *Planning Act*.
4. This By-law shall come into force and take effect on the day of final passing thereof.

Read a first, second and third time, and finally passed this 22 day of June 2026.

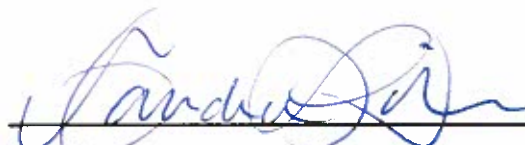

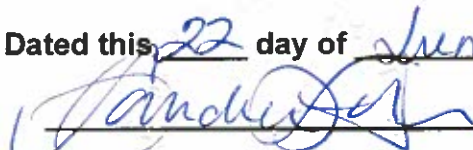
